Adrian Riedo, in the name of the organisation noon.ch, herewith confirms that noon.ch will support the following projects of Concern for Humanity in Delhi in the years 2008 and 2009:

- Chhattarpur Pahari
- Fatehpuri Beri
- Bhatti Kala
- Bhatti Khurd

as described in the project proposal to ASHANET of August 14<sup>th</sup> 2007 and on February 4<sup>th</sup> 2008. noon.ch is participating with 50% in all related expenses. Payments take place on a semi-annual basis, amounting to 49650Rs. The total project budget on the side of noon.ch is limited to a maximum of CHF 3333.- annually, leaving some space for exchange rate fluctuations and other unforeseen developments. Payments will take place on 1.3. and 1.9. The first payment took already place.

Future payments are subject to the conditions below. In particular, they are conditioned to a statement of financial accounts twice a year for the full project, of which one must be audited.

#### **Conditions and Restrictions:**

- USE: The donated money must be used to provide basic education at four centres to a minimum
  of hundred (100) children in the age group 6-14 years. To do this, 2 teachers per centre from the
  community, rental of premises, books & stationery must be paid with this donation.
- FCRA: CFH organisation makes sure that the necessary FCRA (nr 231660479) clearance is maintained.

- CURRENCIES: The maximum funds from noon.ch are spoken in Swiss Francs. Exchange rate fluctuations will impact the exact amount of Indian Rupees reaching the receiving organisation. This effect can be buffered by noon.ch only in a narrow band.
- CONTROL: noon.ch is allowed to send its own observers to CFH Foundation. CFH Foundation
  must provide these observers with all information concerning the activities related to the noon.ch
  donation. In case of unsatisfying reports from these observers, any further donating may be
  shortened, stopped or blocked until the situation has improved accordingly.
- DUTIES: As stated earlier, the donation will be realized in two tranches each year. CFH
  organisation must deliver a status report of its activities and successes related to the noon.ch
  donation every three months. This report authorizes CFH organisation to receive the next tranche
  of the donation.

The status rapport must contain:

- Summary of all realised activities, especially those related to the noon.ch donation
- Proof of realisation on the agreed activities (photos if possible)
- Details of expenses from the noon.ch donation (budget table)
- Deviations from the appendix table (planned use of the donation from noon.ch)
- Comments on the general situation of CFH (finance, staff, interaction with NGO's and government, etc.)
- Outlook for activities and plans for the upcoming three month period
- DUTIES: CFH provides a financial report every 6 months. At least once a year, the financial report must be audited. The FCRA audited financial statement is welcome and can be used as such.
- TERMINATION: This Commitment and Agreement automatically renews itself for one more year, if not recalled two months before. The renewal can be recalled by Fax, letter mail or email.
